#### **Missing Documents**

- Applicants who have not submitted documents such as Verification documents/Apostille or original documents are required to submit
- Deadline
- by August 26(Fri.) 2022
- · How to submit
- by post (submit original documents)
- Didn't accept copy or scan file by E-mail
- Caution
- Admission letter will not be handed if you don't submit all of documents
- Admission will be CANCELLED if documents are not submitted by the deadline

#### **Bank Statement**

- Requirements
  - up to 18,000USD or 21,000,000KRW
- Students in Overseas
  - Bank statement under student or parent's name
  - Submitted by July 15(Fri.) 2022
  - \* Because embassy in each country has different standards for the required balance certificate, Be sure to check the standards with the Korean embassy in advance and issue a balance certificate
- Students in Korea
  - Should submit document from Korea bank under student's name
  - Issued in August 1, 2022 and submitted by August 26, 2022
- Caution
  - Get two copies of the balance certificate. Submit 1 to JBNU,
     1 to the time of visa application
  - Admission letter will not be handed if you don't submit all documents

## [Form 3] Confirmation Letter-support

★ The revision of a policy regarding visa issuance for international students announced by the Ministry of Justice was implemented from 16 May, 2022. Under the newly revised policy, "[Form 3] Confirmation Letter-support" will no longer be used towards proof of financial capability.

For this reason, those who already submitted [Form 3] are required to resubmit the bank statement.

★★ Failure to provide the bank statement when asked will lead to your Admission Letter being refused.

## Pay Tuition Fee

- Payment period
  - [1st Payment Duration] 6 July(Wed)~8 July(Fri), 2022
  - [2<sup>nd</sup> Payment Duration] 25 July(Mon)~27 July(Wed), 2022
  - [3rd Payment Duration] 17 August(Wed)~19 August(Fri), 2022
  - \* You can pay the tuition fee during the one of durations.
  - \* If you will apply for the visa in overseas, please, pay the tuition fee during the 1st payment duration.
- How to pay
  - 1) Print out Tuition fee invoice (<a href="http://all.jbnu.ac.kr/jbnu/euro/">http://all.jbnu.ac.kr/jbnu/euro/</a>)
  - 2) Check account number and amount and pay the fee
  - \* We will notice payment details later
- Caution
- If you didn't pay tuition fee on time, your admission will be canceled
- After paying the tuition fee, you can get Admission letter

### Scholarship

- Selected from students with excellent academic and Language scores
- Academic Score: Calculated as the final average score of the previous course
- Language Score: Calculation of score submitted by 30 June (Thu.) 2022
- \* If language proficiency has improved, submit your certificate by 30 June to admission@jbnu.ac.kr
- Eligibility
- Full-time students who only study without a job in Korea or abroad (Exclude Transfer students. Only for Freshmen)
- Requirements
- 1 Student in Korea: National Health Insurance certificate
- ② Student in Overseas: Confirmation of Full time student(Form1)
- \* Submission deadline: 30 June (Thu), Send to admissiong@jbnu.ac.kr
- \* if you are not full time students, you don't need submit documents
- Method: Reduction when paying tuition fee
- Caution
- If it is confirmed that there is a job in Korea or abroad in the future, all scholarships paid will be refunded.
- Cannot be received together with the research scholarship provided by the professor

#### **Admission Letter**

- Admission Letter?
  - It is a documents that is required when issuing a visa as proof that JBNU permits admission.
- Pick-up date
  - after submit all of documents & pay tuition fee
- How to get
  - 1 Students in overseas: by post (EMS)
  - ② Students in Korea: by post or visit the Graduate School
  - It will be sent to address indicated on application form

- Caution
  - Only students, who paid tuition fee and submitted all of documents will receive Certificate of admission

## Visa Application

- Students in overseas
  - Requirements : Check the application documents with the Korean embassy in each country
  - \* Admission letter and Business registration certificate will be sent by post and E-mail
  - Application date: Apply immediately after receiving admission Letter
  - Processing period: 2 weeks ~ 1 month more
  - \* Visa issuance may take a long time due to COVID19, so prepare the documents in advance and apply as soon as possible
- Students in Korea
  - Application date: 4th week of August (will be announce later)
  - Application place : Office of International affairs
  - Requirements: Application form, fee, passport, Admission Letter, Certificate of tuition fee payment, etc.
    - \* Detailed requirements will be announced later

## Flight Ticket

#### Only for students in overseas

#### Buy Flight ticket

- It is recommended to purchase a flight ticket arriving before Aug 26
- \* Start date of semester: September 1
- \* If you don't attend more than 25% of the class after start of semester, you will receive an F unconditionally. Therefore, please try to enter the Korea by Aug 26 as much as possible

#### Caution

- after buy flight ticket, please send information to <a href="mailto:admissiong@jbnu.ac.kr">admissiong@jbnu.ac.kr</a>
- Only those with a PCR negative confirmation issued within 48 hours can board the aircraft.
- From Airport to Jeonju, use the Airport Limousine Bus/KTX to travel by yourself (To be announced at a later pick up date if provided)
- PCR Testing is required at the Jeon-ju Health Care Center within three days after the entrance

#### Alien registration

- You must complete the alien registration procedure within 90 days of entry and create an alien registration card.
- After preparing the required documents, apply for a visit to the Office of International Affairs

## **Dormitory**

- Application method
  - Automatically applied according to the selections made in the application form
  - If you want to change application, send E-mail until July 15
  - Send an email even if you have a roommate you want to live with

## National Health Insurance

- National Health Insurance?
- Due to the Korean health insurance system, all foreigners are required to subscribe to national health insurance.
- How to Join
- Automatic after finish D-2 alien registration
- Re-entrant : Join insurance after Date of Re-entry
- Fee
- -131,790KRW per month.
- Only! International Students (D-2 visa holder) get a discount
- 2022.3 ~ 2023.2 : 60% discount, pay 52,720KRW/month
- 2023.2 ~: 50% discount, pay 65,900KRW/month
- \* the above amount may vary every year
- How to pay
- after check account information on the bill, pay the fee (You can get the bill by E-mail, post and text message)
- Caution
- If you didn't join insurance, you can't extend visa
- as you subscribe to the National Health Insurance, you can receive one free health checkup every two years.
- if you have a family in Korea, only one of the family members may sign up if you submit documents such as family relationship certificate
